## TERMS AND CONDITIONS

### Rockcote EOY Distributor and Trade Hub Promotion

**1. Promotion Period:**

- The 'Rockcote EOY Distributor and Trade Hub Promotion' ("Promotion") commences on 1 October 2026 and closes on 30 November 2026 ("Promotion Period").

**2. Eligibility:**

- The Promotion is open to individuals who:
  - Make a purchase directly from one of the participating Rockcote Distributors or Rockcote Trade Hubs during the Promotion Period.
  - Are 18 years of age or older.
- The following are ineligible: employees of Rockcote Enterprise, the participating Distributors or Trade Hubs, their affiliates, and their immediate family members (spouse, parent, sibling, or child).

**3. Entry Requirements:**

- **Rockcote Distributors:** To enter, participants must purchase a minimum of \$500 (AUD) of Rockcote products in a single transaction during the Promotion Period.
- **Rockcote Trade Hubs:** To enter, participants must spend a minimum of \$500 (AUD) in a single transaction on any products, including Rockcote products, tools, and accessories, during the Promotion Period.
- Purchases may be made in-store, over the phone, or via email, provided the minimum spend of \$500 (AUD) in a single transaction is met.
- Distributors and Rockcote Trade Hubs may complete entry forms on behalf of customers where required.
- Participants must provide their full name, company name (if applicable), email address, phone number, order date, and receipt number to be eligible. Incomplete or illegible entries may be deemed invalid, and a redraw may occur.
- The invoice number is mandatory on all entry forms and will be verified at the time of the draw to confirm the minimum \$500 (AUD) spend has been met. Any entry that cannot be verified will be deemed invalid and a redraw will occur.
- For every \$500 spent in a single transaction, the participant will receive one (1) entry. For example, a \$1,500 purchase in a single transaction will result in three (3) entries.
- There is no limit to the number of entries per customer.
- A Rockcote Business Development Manager (BDM) or Sales Representative may conduct on-site spot checks at their discretion to ensure entries are completed correctly.

**4. Prize:**

- Each participating Rockcote Distributor and Trade Hub will give away one (1) \$1,000 (AUD) RedBalloon Voucher.
  - The RedBalloon Voucher may be used towards eligible experiences available through RedBalloon, subject to RedBalloon's applicable voucher terms and conditions.
  - The prize is not transferable, exchangeable, or redeemable for cash.
- The prize draw will take place once the Promotion closes. Distributors may choose to conduct the draw at an end-of-year BBQ or event, but a Rockcote BDM or Sales Representative must be present to record and validate the draw.
- All participating stores must complete their prize draw by Friday, 18 December 2026.
- The prize draw at each participating Rockcote Trade Hub may be conducted during its respective end-of-year BBQ or event.
- The winner does not need to be present at the draw to win the prize.
- Prize collection may occur in-store or as otherwise arranged by Rockcote or the participating Distributor.

**5. Winner Selection:**

- The winner will be selected at random from all eligible entries received during the Promotion Period.
- The draw will be conducted by Rockcote and the participating stores by Friday, 18 December 2026.
- Any disputes arising during the draw will be resolved at the sole discretion of Rockcote and the participating Distributors.

**6. Notification of Winner:**

- The winner will be notified in person, by phone, or by email within seven (7) business days of the draw.
- The winner's name may be published on the Rockcote website, social media platforms, and distributor channels. It is the winner's responsibility to advise Rockcote if they do not consent to this publication.
- The winner must respond to Rockcote within seven (7) days of notification to claim the prize.

**7. Claiming the Prize:**

- The winner must claim their prize within seven (7) days of notification.
- Once claimed, the \$1,000 RedBalloon Voucher will be emailed to the winner using the email address provided on their entry form.
- If the prize is unclaimed or the winner cannot be contacted within this period, a redraw may occur at the discretion of Rockcote and the participating Distributor Stores.

**8. General Conditions:**

- The prize is not transferable, exchangeable, or redeemable for cash.
- By entering the Promotion, participants agree to be bound by these Terms and Conditions and consent to the use of their personal information by Rockcote and the participating Distributors for the purposes of conducting and promoting the Promotion.
